Product/Craft Vendor Application

Process of Application:

Craft/Product vendors who wish to participate at the Country Festival event must submit an application and be approved by the City of Tolleson. We limit the number of booth space to ensure a high quality show for vendors and guests. Due to limited space and the process of selection, some otherwise qualified applicants may be declined.

The city has a business license that you will need to get. It is for the year.

\$60.00 for craft/product vendors if you are selling.

You can pay online or in person at city hall, 9555 W. Van Buren.

Selection Process:

1. The City of Tolleson will select vendors based on quality and the needs of the city for this event. **All applications need to be mailed, emailed or dropped off by due date November 15th.** We will select the vendors and notify the vendors that have been selected within one week.
2. All decisions are final and cannot be appealed.
3. Only items, which have been approved by the City of Tolleson are allowed at the event. Any items not selected or approved are subject to removal at any time during the event.
4. The City of Tolleson designates all spaces.
5. All setup and equipment is the responsibility of each vendor, electricity will be provided in ramada areas only. Food trucks must provide their own generators.
6. The Tolleson Teen Council will be selling hot chocolate and coffee. **No vendors can sell these items.**
